#### **Position Overview**

The Machine Operator will run molding machines and secondary operations as required while maintaining and confirming the quality of our products.

## **Position Responsibilities/Essential Functions**

- Safety is everyone's responsibility
- Visually inspect and assemble parts to quality specifications, being aware of critical visual and dimensional defects and determine acceptability of the parts, based on customer specifications
- Ensure accurate packaging and traceability of product, including the correct labeling and accurate part count
- Communicate with supervisor/lead operator regarding any unacceptable parts, malfunctions of the production process within their workstation, or safety issues
- Utilize route sheets and work instructions to ensure parts meet both customer and internal requirements
- Remove parts from injection molding machines during gate tended operations
- Make use of auxiliary equipment to aid in the assembly process. Examples: sonic welders, heat sealers/shrink wrappers, and granulators
- Perform routine cleaning of machines and work areas
- Account for and record production and scrap counts
- Follow all HACCP (Hazard and Critical Control Points) and GMP (Good Manufacturing Practices)
- Expected to be available for work in both the Somers or Ellington production facilities. Job location may be shifted daily or weekly to meet production needs
- Regular, on-time attendance at work is an essential function of every job at Dymotek
- Support the organization's needs in various functions

### Minimum Qualifications/Skills

- Ability to work independently
